### Section 4 First Aid Measures

**Emergency First Aid Procedures** 

**Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if any discomfort continues.

**Skin contact:** Wash skin with soap and water. If skin irritation or rash occurs: Get medical advice/attention. **Eye contact:** Flush eyes thoroughly with water for at least 15 minutes. Remove contact lenses, if present and easy to do. Get medical attention if irritation develops and persists.

### Section 5 Firefighting Procedures

Suitable extinguishing media: Water fog. Dry chemical powder. Carbon dioxide (CO2).

#### Section 6 Spill or Leak Procedures

Wear appropriate protective equipment and clothing during clean-up. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained.

Methods and materials for containment and cleaning up:

Large Spills: Remove sources of ignition. Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. For waste disposal, see Section 13 of the SDS.

**Environmental precautions:** Avoid release to the environment. Environmental manager must be informed of all major releases.

### Section 7 Handling and Storage

**Precautions for safe handling:** Do not breathe mist or vapor. Do not smoke or use open fire or other sources of ignition. Do not get in eyes, on skin, on clothing. Use with adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.
